For the month of June 2014, Copa Holdings' system-wide passenger traffic (RPM) increased 13.0% year over year, while capacity increased 12.2%. As a result, system load factor for June 2014 was 77.4%, a 0.5 percentage point increase when compared to June 2013.

International passenger traffic grew 15.4%, while capacity increased 14.4%. This resulted in a load factor of 77.4%, a 0.7 percentage point increase when compared to June 2013. For the month, International capacity represented 98.5% of total capacity.

Domestic traffic, represented wholly by Colombian domestic service, decreased 53.7%, while capacity decreased 50.9%. As a result, domestic load factor for the month decreased 4.7 percentage points to 76.6%. For the month, domestic capacity represented 1.5% of total capacity.

Copa Holdings is a leading Latin American provider of passenger and cargo services. The Company, through its operating subsidiaries, provides service to 67 destinations in 29 countries in North, Central and South America and the Caribbean with one of the youngest and most modern fleets in the industry, consisting of 94 aircraft: 68 Boeing 737NG aircraft and 26 EMBRAER-190s.
