## Copa Holdings Announces Monthly Traffic Statistics For April 2015

For the month of April 2015, Copa Holdings' system-wide passenger traffic (RPM) increased 1.6% year over year, while capacity increased 7.0%. As a result, system load factor for April 2015 was 72.7%, a 3.9 percentage point decrease when compared to April 2014.
