## Copa Holdings Announces Monthly Traffic Statistics for March 2015

For the month of March 2015, Copa Holdings' system-wide passenger traffic (RPM) increased 2.4% year over year, while capacity increased 7.3%. As a result, system load factor for March 2015 was 72.2%, a 3.4 percentage point decrease when compared to March 2014.
