For the month of August 2018, Copa Holdings' system-wide passenger traffic (RPMs) increased 2.8% year over year, while capacity (ASMs) increased 4.9%. As a result, system load factor for the month was 83.4%, 1.7 percentage points lower than August 2017.

The Company, through its operating subsidiaries, provides service to 80 destinations in 32 countries in North, Central and South America and the Caribbean with one of the youngest and most modern fleets in the industry, consisting of 102 aircraft: 82 Boeing 737NG aircraft, 1 Boeing 737MAX and 19 EMBRAER-190s.
