## Copa Holdings Announces Monthly Traffic Statistics for February 2019

PANAMA CITY, March 13, 2019 /PRNewswire/ -- Copa Holdings, S.A. (NYSE: CPA), today released preliminary passenger traffic statistics for February 2019:

For the month of February 2019, Copa Holdings' system-wide passenger traffic (RPMs) increased 0.7% year over year, while capacity (ASMs) remained flat. As a result, system load factor for the month was 83.6%, 0.6 percentage points higher than February 2018.

*Copa Holdings is a leading Latin American provider of passenger and cargo services. The Company, through its operating subsidiaries, provides service to 81 destinations in 33 countries in North, Central and South America and the Caribbean with one of the youngest and most modern fleets in the industry, consisting of 106 aircraft: 6 Boeing 737 MAX9s, 82 Boeing 737NGs aircraft and 18 Embraer-190s.
