For the month of May 2016, Copa Holdings' system-wide passenger traffic (RPM) increased 3.9% year over year, while capacity decreased 0.3%. As a result, system load factor for May 2016 was 77.6%, a 3.1 percentage point increase when compared to May 2015.

Copa Holdings is a leading Latin American provider of passenger and cargo services. The Company, through its operating subsidiaries, provides service to 76 destinations in 31 countries in North, Central and South America and the Caribbean with one of the youngest and most modern fleets in the industry, consisting of 100 aircraft: 77 Boeing 737NG aircraft and 23 EMBRAER-190s.
