For the month of November 2017, Copa Holdings' system-wide passenger traffic (RPMs) increased 10.6% year over year, while capacity (ASMs) increased 8.5%. As a result, system load factor for the month was 82.2%, a 1.6 percentage point increase when compared to November 2016.

Copa Holdings is a leading Latin American provider of passenger and cargo services. The Company, through its operating subsidiaries, provides service to 75 destinations in 31 countries in North, Central and South America and the Caribbean with one of the youngest and most modern fleets in the industry, consisting of 100 aircraft: 80 Boeing 737NG aircraft and 20 EMBRAER-190s.
