For the month of July 2016, Copa Holdings' system-wide passenger traffic (RPM) increased 9.8% year over year, while capacity (ASM) increased 1.1%. As a result, system load factor for July 2016 was 86.1%, a 6.9 percentage point increase when compared to July 2015.
