For the month of October 2016, Copa Holdings' system-wide passenger traffic (RPMs) increased 13.7% year over year, while capacity (ASMs) increased 1.4%. As a result, system load factor for October 2016 was 83.3%, a 9.0 percentage point increase when compared to October 2015.

Copa Holdings is a leading Latin American provider of passenger and cargo services. The Company, through its operating subsidiaries, provides service to 74 destinations in 31 countries in North, Central and South America and the Caribbean with one of the youngest and most modern fleets in the industry, consisting of 99 aircraft: 78 Boeing 737NG aircraft and 21 EMBRAER-190s.
