## Copa Holdings Announces Monthly Traffic Statistics for October 2016

PANAMA CITY, Nov. 10, 2016 /PRNewswire/ -- Copa Holdings, S.A. (NYSE: CPA), today released preliminary passenger traffic statistics for October 2016:

For the month of October 2016, Copa Holdings' system-wide passenger traffic (RPMs) increased 13.7% year over year, while capacity (ASMs) increased 1.4%. As a result, system load factor for October 2016 was 83.3%, a 9.0 percentage point increase when compared to October 2015.
