## Copa Holdings Announces Monthly Traffic Statistics For November 2015

PANAMA CITY, Panama, Dec. 16, 2015 /PRNewswire/ -- Copa Holdings, S.A. (NYSE: CPA), today released preliminary passenger traffic statistics for November 2015:

For the month of November 2015, Copa Holdings' system-wide passenger traffic (RPM) increased 2.6% year over year, while capacity increased 2.6%. As a result, system load factor for November 2015 was 74.0%, a similar load factor when compared to November 2014.
