For the month of February 2017, Copa Holdings' system-wide passenger traffic (RPMs) increased 6.9% year over year, while capacity (ASMs) increased 1.2%. As a result, system load factor for February 2017 was 81.0%, a 4.3 percentage point increase when compared to February 2016.

The Company, through its operating subsidiaries, provides service to 73 destinations in 31 countries in North, Central and South America and the Caribbean with one of the youngest and most modern fleets in the industry, consisting of 101 aircraft: 80 Boeing 737NG aircraft and 21 EMBRAER-190s.
