## Copa Holdings Announces Monthly Traffic Statistics For February 2017

For the month of February 2017, Copa Holdings' system-wide passenger traffic (RPMs) increased 6.9% year over year, while capacity (ASMs) increased 1.2%. As a result, system load factor for February 2017 was 81.0%, a 4.3 percentage point increase when compared to February 2016.
