Copa Holdings Announces Monthly Traffic Statistics For February 2016

PANAMA CITY, March 14, 2016 /PRNewswire/ -- Copa Holdings, S.A. (NYSE: CPA), today released preliminary passenger traffic statistics for February 2016:

1. Available seat miles - represents the aircraft seating capacity multiplied by the number of miles the seats are flown.

For the month of February 2016, Copa Holdings' system-wide passenger traffic (RPM) increased 4.7% year over year, while capacity increased 5.0%. As a result, system load factor for February 2016 was 76.8%, a 0.2 percentage point decrease when compared to February 2015.

Copa Holdings is a leading Latin American provider of passenger and cargo services. The Company, through its operating subsidiaries, provides service to 75 destinations in 31 countries in North, Central and South America and the Caribbean with one of the youngest and most modern fleets in the industry, consisting of 100 aircraft: 77 Boeing 737NG aircraft and 23 EMBRAER-190s.
