## Copa Holdings Announces Monthly Traffic Statistics For July 2019

PANAMA CITY, Aug. 9, 2019 /PRNewswire/ -- Copa Holdings, S.A. (NYSE: CPA), today released preliminary passenger traffic statistics for July 2019:

For the month of July 2019, Copa Holdings' system-wide passenger traffic (RPMs) decreased 2.6% year over year, while capacity (ASMs) decreased 0.6%. As a result, system load factor for the month was 86.6%, 1.7 percentage points lower than July 2018.

*Copa Holdings is a leading Latin American provider of passenger and cargo services. The Company, through its operating subsidiaries, provides service to 80 destinations in 32 countries in North, Central and South America and the Caribbean with one of the youngest and most modern fleets in the industry, consisting of 104 aircraft: 6 Boeing 737 MAX9s, 82 Boeing 737NGs aircraft and 16 Embraer-190s.
