### Copa Holdings Announces Monthly Traffic Statistics For January 2017

PANAMA CITY, Feb. 15, 2017 /PRNewswire/ -- Copa Holdings, S.A. (NYSE: CPA), today released preliminary passenger traffic statistics for January 2017:

For the month of January 2017, Copa Holdings' system-wide passenger traffic (RPMs) increased 10.7% year over year, while capacity (ASMs) increased 5.7%. As a result, system load factor for January 2017 was 83.7%, a 3.8 percentage point increase when compared to January 2016.

Copa Holdings is a leading Latin American provider of passenger and cargo services. The Company, through its operating subsidiaries, provides service to 73 destinations in 31 countries in North, Central and South America and the Caribbean with one of the youngest and most modern fleets in the industry, consisting of 100 aircraft: 79 Boeing 737NG aircraft and 21 EMBRAER-190s.
