For the month of June 2018, Copa Holdings' system-wide passenger traffic (RPMs) increased 10.9% year over year, while capacity (ASMs) increased 8.2%. As a result, system load factor for the month was 84.3%, 2.0 percentage points higher than June 2017.

Copa Holdings is a leading Latin American provider of passenger and cargo services. The Company, through its operating subsidiaries, provides service to 80 destinations in 32 countries in North, Central and South America and the Caribbean with one of the youngest and most modern fleets in the industry, consisting of 101 aircraft: 82 Boeing 737NG aircraft and 19 EMBRAER-190s.
