For the month of July 2013, Copa Holdings' system-wide passenger traffic (RPM) increased 14.4% year over year, while capacity increased 11.3%. As a result, system load factor for July 2013 was 80.8%, a 2.2 percentage point increase when compared to July 2012.

International passenger traffic grew 16.2%, while capacity increased 12.8%. This resulted in a load factor of 80.7%, a 2.3 percentage point increase when compared to July 2012. For the month, International capacity represented 96.8% of total capacity.

Domestic traffic, represented wholly by Colombian domestic service, decreased 20.8%, while capacity decreased 20.9%. As a result, domestic load factor for the month remained at 83.0%. For the month, domestic capacity represented 3.2% of total capacity.

Copa Holdings is a leading Latin American provider of passenger and cargo services. The Company, through its operating subsidiaries, provides service to 65 destinations in 29 countries in North, Central and South America and the Caribbean with one of the youngest and most modern fleets in the industry, consisting of 87 aircraft: 61 Boeing 737NG aircraft and 26 EMBRAER-190s.
